



## TERMS & CONDITIONS

Please take the time to read and understand the conditions of booking set out below prior to booking your retreat with us.

### RETREAT CONFIRMATION:

Acceptance into the retreat is subject to the following:

- Online booking completion with agreement to the T&C's
- Receipt of deposit and or payment in full
- Confirmation from Artful Retreats

Admission is at the sole discretion of Artful Retreats and we reserve the right to refuse admission on any grounds, in which case all monies paid, will be refunded.

### PAYMENTS:

All Prices and Payments are in Euros.

You will be offered two payment methods:

1. **ONLINE PAYMENT: CREDIT CARD.** This payment is automatically taken in full and included the 30% non refundable deposit.
2. **OFFLINE PAYMENTS: Via BANK TRANSFER (preferred) or CREDIT CARD :** This payment can be done in full or in two instalments. 30% deposit for confirmation of the reservation and balance payment 6 weeks before arrival. All bank charges must be charged to you otherwise there will be a shortfall in your payment we receive. Should the deposit / balance payment not be received within the time frame specified, Artful Retreats reserves its right to cancel your booking(s) and to charge the applicable cancellation fees set out below.

**CANCELLATIONS:**

If you cancel your booking, cancellation fees will apply. A cancellation will only be effective when we receive written confirmation of the cancellation and have responded having acknowledged the cancellation.

If you cancel your retreat:

- 30 days or more prior to the retreat start date, we will retain the deposit;
- 30 days or fewer prior to the retreat date, we will retain 100% paid by you in connection with the booking.
- Cancellations due to travel restrictions or quarantine requirements to either the country of departure or arrival are treated with care and offer two possibilities: rebooking on a later date retreat or full refund.

Ensure you have the most up to date information with regards to Greece and your own Government guidelines for international travel, required documentation and testing requirements. Artful Retreats does not take any responsibility for your travel in & out of Greece, therefore we also strongly advise you to take out travel insurance at the time of booking which will help cover any cancellation fees. If you fail to join a retreat, arrive after the

commencement of the retreat, or leave the retreat prior to its completion, no refund will be made.

### BOOKING CHANGES:

If you wish to transfer from one retreat to another or transfer your booking to a third party you must notify us at least 30 days prior to the retreat date.

A fee of 50€ per person per change will apply. If you notify us less than 30 days prior to the retreat date the refund policy applicable to cancellations will apply.

Transfers to a third party are only permitted upon written request and can only be made to the retreat that was booked for.
